

## Our recent climate security work

Third Party Validation, Monitoring and Research Peer Review of Delivering Accelerated Family Planning in Pakistan (DAFPAK) | FCDO Pakistan | 2019 – 2023

In 2022, floods in Pakistan displaced 33 million people. In total, 13,000 people were injured, and 2.2 million homes and nearly 2,000 health facilities were damaged across 94 districts. DAFPAK pivoted its funding to provide emergency services for family planning and health, including maternal and child health. The implementing partners collaborated with Pakistan's government departments of Health and Population Welfare. M&C Saatchi supported a behavioural change communication campaign, directly engaging clients in medical camps, and through television, radio, and social media campaigns.

Peacebuilding Evaluation, Analysis, Research, and Learning (PEARL) | USAID Center for Violence and Conflict Prevention (CVP) | 2022 – 2026

**USAID** / Kenya and East Africa Violence and Conflict Assessment, April 2023 – February 2024: Integrity conducted a Violence and Conflict Assessment (VCA) for USAID / Kenya and East Africa examining the relationship between natural resource management, environmental security, and conflict dynamics. The VCA aimed to prevent violence and promote peace in northern Kenya by identifying opportunities to mitigate conflict over natural resources and respond to climate-related challenges across the Mission's portfolio.

## Global Monitoring Evaluation and Learning (GMEL) Partnership | FCDO | 2019 – 2023

We conducted a review of the Joint Funds Unit (JFU) climate security fund. In 2022, the JFU ring-fenced £2 million of non-ODA funding to pilot interventions in which climate change and biodiversity loss interact with, and exacerbate, conflict and insecurity. Our review aimed to identify lessons and recommendations to inform future climate security work under the new Integrated Security Fund (ISF).
