Peacebuilding Evaluation, Analysis, Research, and Learning (PEARL) USAID / Bureau for Conflict Prevention and Stabilization 2022 – 2026

USAID / Uganda Securing Peace and Promoting Prosperity in Karamoja (ESKIL) Activity Evaluation, September 2023 – present: Integrity is conducting a final evaluation of ESKIL, the Mission's flagship peacebuilding activity in the Karamoja region. Findings are intended to inform political violence and social cohesion programming, as well as contribute to the evidence base for conflictsensitive development.

USAID / Kenya and East Africa Violence and Conflict Assessment, April 2023 – February 2024: Integrity conducted a Violence and Conflict Assessment (VCA) for USAID / Kenya and East Africa examining the relationship between natural resource management, environmental security, and conflict dynamics. The VCA aimed to prevent violence and promote peace in northern Kenya by identifying opportunities to mitigate conflict over natural resources and respond to climate-related challenges across the Mission's portfolio.

Monitoring, Evaluation, and Learning Support Activity (MELS) USAID / South Sudan 2021 – 2026

We support implementation of USAID / South Sudan's Strategic Framework through tailored monitoring and evaluation services to enhance Mission programmes. In a dynamic operating environment, our flexible, demand-driven technical, analytic, and advisory support strengthens collaboration, learning, and adapting. Rapid Evaluation of FCDO's Better Regional Migration Management Programme (BRMM) FCDO Kenya and Ethiopia 2022 – 2023

We delivered a rapid evaluation of the BRMM programme to enable learning about the potential and effectiveness of interventions, and their relevance in making migration more productive in East Africa and Horn of Africa (EHOA). The evaluation covered International Labour Organization (ILO) and International Organization for Migration (IOM) programme activities in Ethiopia and Kenya. Interviews were conducted with key stakeholders in government organisations and civil society, and a number of case studies were prepared.

Somalia Monitoring and Learning Program II USAID / Bureau for Humanitarian Assistance 2022 – 2027

We give continuous feedback to BHA, implementing partners, and other key stakeholders on project and activity progress, support rapid decision making, and facilitate ongoing learning and adaptation.
