✓ We work with USAID/CVP to design innovative analytical services and learning opportunities for the agency's dynamic global peacebuilding and conflict prevention portfolio. This includes scalable violence and conflict assessments, technical assessments in key issue areas such as atrocity prevention, performance and impact evaluations, learning exchanges, context monitoring, and scenario planning support.

Asia Bureau Monitoring, Evaluation and Learning Support Mechanism (Asia MEL), USAID Asia Bureau, 2023 – 2027
